Re: Emergency Methane Action

## Dear Governor:

The 20 organizations and 20 faith leaders listed below are calling on you, as Governor, to take bold and decisive steps to minimize the impacts of climate change on the people of our state and its environment by reducing methane emissions from the fracked gas and power industries.

Natural gas is mostly methane. Leaking and venting of unburned methane from natural gas infrastructure – from well head to power plant – is now one of the greatest contributors to the climate crisis. Methane is 100 times more potent than carbon dioxide at trapping heat over the first 10 years in the atmosphere, which is the most critical time to act to avert the worst impacts of the climate crisis.

North Carolina is already experiencing severe impacts from the climate crisis and, without strong leadership at the state level, these impacts will accelerate beyond humanity's control.

2016 was the third year in a row to set the average global temperature record. The recent series of floods, droughts, and forest fires in North Carolina is unprecedented. Farms and forests are directly impacted. Communities along our rivers are being repeatedly inundated due to torrential rainfalls. Local governments along the coast increasingly face nuisance flooding and many areas will soon face massive property losses from sea level rise. The entire North Carolina economy is at risk.

Tragically, those least responsible for causing the climate crisis – low-wealth communities and people of color – are being hurt disproportionately.

Our resolution asks you to take three steps to help slow the climate crisis:

Eliminate use of fracked gas in North Carolina;

- Reduce all natural gas use unless methane emissions are greatly reduced; and
- Oppose new gas-fired power plants and fracked gas pipelines.

Our state should be moving quickly to replace fossil fuels with cheaper clean energy resources – not toward a destructive energy future that relies on fracked gas.

The Trump Administration is going in the wrong direction, leading us further down the road to climate chaos. It is up to the states, through their governors and environmental agencies, to take the countermeasures needed.

North Carolina can be a leader by taking these measures to reduce methane emissions and slow down the climate crisis.

We will be glad to discuss our Emergency Methane Action campaign with you, as well as steps you and state agencies can take.

Thank you in advance for considering taking a leadership role in the global struggle to slow the climate crisis.
